RESOLUTION NO. 10-220

**RESOLUTION AUTHORIZING AN AGREEMENT WITH THE
TWO RIVERS WATER RECLAMATION AUTHORITY TO
PROVIDE Bioxide TREATMENT TO SEWAGE AT THE
BODMAN PLACE PUMP STATION**

Mr. Murphy offered the following resolution and moved its adoption:

WHEREAS, the Two Rivers Water Reclamation Authority (hereinafter, "the Authority") and the Borough of Red Bank are parties to an Agreement dated September, 15, 1968 pursuant to which the Authority provides sewer treatment service to Red Bank; and

WHEREAS, pursuant to that agreement, the Authority receives sewage from Red Bank's collection system, which is ultimately transported to the Authority's treatment facility for processing; and

WHEREAS, the Authority presently must treat Red Bank's sewage, at the point of connection with its system, to reduce the presence of hydrogen sulfide and other hazardous gases; and

WHEREAS, Red Bank has determined that it must treat its sewage "within" its collection system to reduce the presence of hydrogen sulfide and other hazardous gases in order to reduce or prevent further damage to its collection system and to reduce the presence of hydrogen sulfide and other hazardous gases within its collection system; and

WHEREAS, the Authority bids for the supply, delivery and injection of Bioxide into the Authority's collection system at various sites and as it is in the best interest of both the Authority and Red Bank to see that Bioxide is added to Red Bank's collection system; and

WHEREAS, the Authority will bill the Borough for the amount of bioxide used by the Borough at the Authority's publicly bid contract price with its bioxide supplier;

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Red Bank that the Mayor and the Borough Clerk are hereby authorized to execute an agreement, with the Two Rivers Water Reclamation Authority, subject to review by the Borough Attorney, for the provision of bioxide for sewage treatment at the Bodman Place Pump Station, and/or such other locations deemed advisable, at the Authority's publicly bid contract price for that item; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be sent to the Two Rivers Water Reclamation Authority.
