4. APPLICANT MUST RETURN COMPLETED APPLICATION TO THE RED BANK POLICE DEPARTMENT. THE BOROUGH OF RED BANK CHARGES A \$25.00 FILING FEE. (CASH OR MONEY ORDER ONLY)
5. APPLICANT MUST PRESENT TWO (2) VALID FORMS OF IDENTIFICATION; ONE HAVING A PHOTO. (CREDIT CARDS ARE NOT ACCEPTED AS VALID FORMS OF IDENTIFICATION)
