RESOLUTION NO. 18-242**

**A RESOLUTION AWARDING A PROFESSIONAL SERVICES CONTRACT TO CME ASSOCIATES
FOR ENGINEERING SERVICES FOR THE EAST SIDE PARK & MOHAWK POND IMPROVEMENTS**

Councilman Yngstrom offered the following resolution and moved its approval:

WHEREAS, the Borough of Red Bank is in need of contracting for professional engineering services to provide construction administration services for the East Side Park and Mohawk Pond Improvements; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., requires a resolution authorizing the award of the contract for professional services without competitive bids and that the contract itself must be available for inspection; and

WHEREAS, CME Associates has been previously authorized to provide services for the East Side Park & Mohawk Pond Improvements and has made significant progress to complete the project; and

WHEREAS, CME Associates has provided a proposal dated September 26, 2018 to provide the needed services to complete the project.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Red Bank that the Mayor and the Clerk of the Borough of Red Bank are hereby authorized to execute and attest to an agreement with CME Associates for professional engineering services for the East Side Park and Mohawk Pond Improvements to be completed on or before July 1, 2019, at a fee not to exceed \$63,500.00, pursuant to Proposal No. 2018-224 dated September 26, 2018. This contract is awarded without competitive bids as a "professional services contract" in accordance with N.J.S.A. 40A:11-5 (1)(a)(l) of the Local Public Contract Law.

BE IT FURTHER RESOLVED, that the account to be charged is C-04-17-009-398 in an amount not to exceed \$63,500.00 and that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference.
