A RESOLUTION AWARDING A CONTRACT PURSUANT TO THE LOCAL PUBLIC
CONTRACTS LAW TO GR MASONRY WORK, LLC., BELLEVILLE, NEW JERSEY,
FOR EAST SIDE PARK AND MOHAWK POND IMPROVEMENTS

Councilman Yngstrom offered the following resolution and moved its approval:

WHEREAS, the Borough of Red Bank advertised for bids for a public improvements project known as the East Side Park and Mohawk Pond Improvements; and

WHEREAS, on September 25, 2018, the Borough of Red Bank received bids for construction of the East Side Park and Mohawk Pond Improvements as follows:

WHEREAS, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq., and upon recommendation of Laura J. Neumann, Borough Engineer, GR Masonry Work, LLC. has been determined to be the lowest responsible bidder,

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Red Bank that a contract is hereby awarded to GR Masonry Work, Belleville, New Jersey, in the amount of \$427,325.00 for the East Side Park & Mohawk Pond Improvements for base bid items 1 through 41 inclusive, to be completed on or before July 1, 2019, and that the Mayor and the Clerk of the Borough of Red Bank are authorized to execute and attest to an agreement with GR Masonry, LLC., Belleville, New Jersey, pursuant to bid specifications, and in a form approved by the Borough Attorney; and

BE IT FURTHER RESOLVED, that the Borough Clerk shall publish a notice of this action in the official newspaper of the Borough within 10 days from the adoption of this Resolution; and

BE IT FURTHER RESOLVED, the account to be charged is C-04-17-009-498 in an amount not to exceed \$427,325.00 and that the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference.
